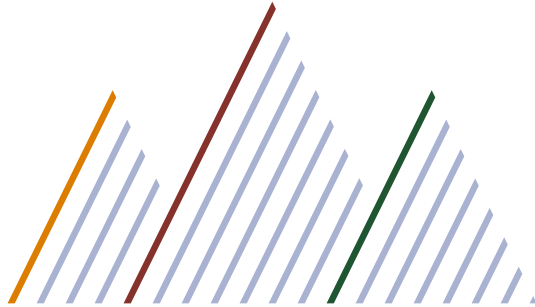

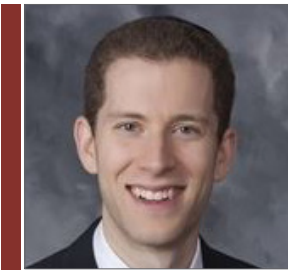

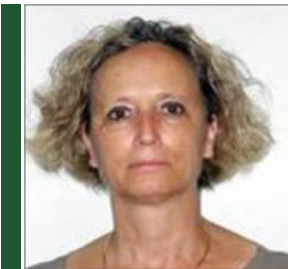


## **FRED DOBB**

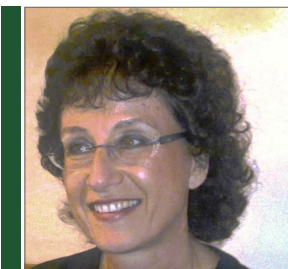


## **SHLOMIT DOTEN-GISSIN**

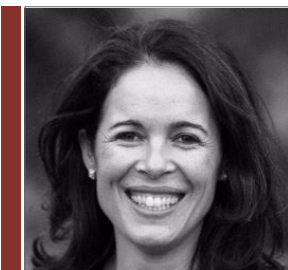


## DAVID YEDID

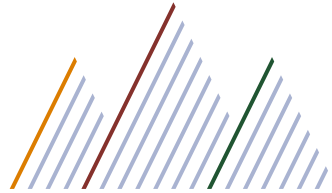
